2. That the expenditure of \$51,000.00 is hereby authorized out of the Capital Outlay Fund (Fund 245), that the expenditure of \$1,418.39 is hereby authorized out of the Capital Outlay Unallocated Reserve Fund (Fund 245), and that the expenditure of \$24,281.61 is hereby authorized out of the Park Service District Fund (Fund 11730) of the City of San Diego solely and exclusively for the purpose of providing funds for SOUTH BAY PARK AND RECREATION CENTER SPORTS FIELD AND AREA LIGHTING, Base Bid and Additive Alternate 1, in the City of San Diego, and related costs.
