BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. Associated Concrete Products, 2. Precast Concrete Co., and 3. Brooks Products, Inc. are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of CONCRETE UTILITY AND WATER METER BOXES as may be required for a period of one (1) year beginning July 1, 1977 through June 30, 1978 per prices on file in the Purchasing Department as follows:

1. Associated Concrete Products for Section I - Items 1 and 2, plus sales tax, terms net 30 days, with an option to renew for an additional one (1) year period at prices not to exceed 7% of bid prices,
2. Precast Concrete Co. for Section II; Items 6, 7, and 8, plus sales tax, terms 2% 10 days, and
3. Brooks Products, Inc. for Section II, Items 3, 4, and 5, plus sales tax, terms net 30 days.
