That the City Manager be and he is hereby authorized and empowered to execute for and on behalf of said City, an agreement with THE SWA GROUP, for park and recreational planning, landscape architectural, architectural, environmental, and feasibility study services required for the Master Development Planning for RANCHO BERNARDO COMMUNITY PARK, under the terms and conditions set forth in the form of Agreement on file in the Office of the City Clerk as Document No. 759625.

BE IT FURTHER RESOLVED, that the expenditure of \$60,000 is hereby authorized out of Park Service District Funds 11100, 11101, 11102, 11103, 11105, 11106, 12100, 12101, 12102, 12105, and 12106 of The City of San Diego, solely and exclusively for the purpose of providing funds for planning design and related expenses as described above.
