
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of the City of San Diego, an Agreement with the SAN DIEGO AND ARIZONA EASTERN RAILWAY COMPANY, a corporation of the State of Nevada, bearing date of January 28, 1977, pursuant to which the City acquires the right to construct, reconstruct, maintain and operate a trunk sewer or sewers, in, upon, along, across and beneath the railroad property being a portion of Lot 41 of the Ex-Mission Lands of San Diego, as more particularly described in said Agreement, the form of which is on file in the office of the City Clerk as Document No. 759631.

BE IT FURTHER RESOLVED, that the expenditure of \$5,700 from Sewer and Revenue Bond Fund No. 506, to cover acquisition expenses of the Encanto Trunk Sewer Replacement, Phase II, in Southeast San Diego, is hereby authorized.

BE IT FURTHER RESOLVED, that the City Clerk is authorized and directed to deliver said Agreement and a certified copy of this resolution to the Property Director for further handling.
