APPROVING MAP OF DALEY BUSINESS PARK UNIT NO. 3

JUN 15 1977

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by FRANK M. POWELL, a Registered Civil Engineer, entitled "DALEY BUSINESS PARK UNIT NO. 3 Being a subdivision of all of Lots 3 and 8 and portions of Lots 4 and 7, all being in Block 20 of Rosedale, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 826, filed in the office of the County Recorder of San Diego County, January 21, 1897; together with a portion of the west half of Olive Avenue, adjoining said Lots 7 and 8 on the east, as closed and vacated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Viewridge Avenue for public purposes; and said street is hereby declared to be a public street and dedicated to the public use.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the

construction and maintenance of sewer and drainage facilities, together with the easements for emergency access with the right of ingress and egress of emergency vehicles for access to the properties within the subdivision or to other adjacent or nearby lands, for emergency purposes, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street is accepted on behalf of the public as heretofore stated; and that those certain easements for sewer and drainage facilities and emergency access as granted and shown on this map, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of Board of Supervisors of the County of San Diego, California.
