

RESOLUTION No. 218590 (R-77-2254)

Adopted on JUN 15 1977

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the expenditure of \$10,000 from Gas Tax Fund 220 of The City of San Diego is hereby authorized solely and exclusively for the purpose of providing funds for relocating 30⁺ water meters and relocating one fire hydrant as part of City's contribution for the improvement of IMPERIAL AVENUE, from 400 feet east of Euclid Avenue to 61st Street, under the Municipal Improvement Act of 1911, supplementing Resolution No. 218094 in this amount.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to do by City Forces all necessary work in conjunction with the above-referenced project pursuant to the recommendation of the City Manager and the submission of his estimates indicating said work can be done more economically by City Forces than if let by contract.
