That the expenditure of \$60,000 is hereby authorized out of the Capital Outlay Fund 245 of The City of San Diego, solely and exclusively for the purpose of providing funds for material, equipment, engineering and costs related to the construction of the OTAY LAKE DOCK.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to do by City forces the necessary work for the construction of the Otay Lake Dock, pursuant to recommendation of the City Manager and submission of estimates by him indicating that said work can be done by City forces more economically than if let by contract.
