

**RESOLUTION No. 218598** (R. 77-1978)



BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a Lease Agreement with CALIMAR, INC., as Lessee, leasing portions of Building Nos. 2010 and 2050, and adjacent vacant land area at Brown Field Airport, consisting of 6,800 square feet and 11,044 square feet respectively and 10,400 square feet of adjacent vacant land, for use of packing, freezing and storing of fish food, raising of shrimp and various sea life and for such other related or incidental purposes as may first be approved in writing by the City and for no other purpose, at a rental of \$1,800 per month for a term of three years, under the terms and conditions set forth in the form of lease agreement on file in the office of the City Clerk as Document No. 759699.

That the City Clerk is hereby authorized and directed to deliver said lease agreement and a certified copy of this resolution to the Property Director for further handling.
