BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the COUNTY OF SAN DIEGO for the purpose of receiving \$9,000 from said County for funding one-half of the production costs of Mainstream Magazine, pursuant to the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document



BE IT FURTHER RESOLVED, that the expenditure of \$9,000 from Fiscal Year 1977 Revenue Sharing funds (Fund 267) of The City of San Diego, be hereby authorized, solely and exclusively, for the purpose of funding one-half of the production costs of Mainstream Magazine.

BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with ABLE-DISABLED ADVOCACY, INC., for the purpose of providing funds to defray the production costs of Mainstream Magazine in an amount up to and not exceeding \$18,000 for the six-month period commencing June 1, 1977 and ending on November 30, 1977, pursuant to the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document
