

RESOLUTION No. 218615 (R-77-2190)


Adopted on JUN 15 1977

KENDALL, husband and wife, as joint tenants, executed in favor of The City of San Diego, bearing date of April 25, 1977, conveying to said City for public street purposes an easement over a portion of Lot 94 of Rosemont Addition to Encanto Heights, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named RADIO DRIVE.
