WHEREAS, the Planning Commission held public hearings on January 6, March 3, and March 31, 1977, to consider the new "Mira Mesa Community Plan"; and

WHEREAS, the Planning Commission approved and recommended to the City Council adoption of the new "Mira Mesa Community Plan" and that the resolution adopting the existing "Mira Mesa Community Plan," be rescinded; and

WHEREAS, City Council Policy 600-7, requires that public hearings to consider revisions of the "Progress Guide and General Plan for The City of San Diego" shall be scheduled concurrently with all public hearings on proposed community plans; and

WHEREAS, the Planning Commission of The City of San Diego has held concurrent public hearings to consider the new "Mira Mesa Community Plan" and amendment of the General Plan in order to retain consistency between said plans; and

On January 6, March 3, and March 31, 1977, the Planning Commission adopted and recommended for adoption by the City Council an amended General Plan; and

WHEREAS, California Government Code, Section 65869, provides that mandatory elements of the General Plan may not be amended more than three times per year; and

WHEREAS, it is the intention of the City Council to consider amendments to the "Progress Guide and General Plan for the City of San Diego" at hearings conducted on a semi-annual basis; and

WHEREAS, it is the intention of the City Council to conduct a public hearing on proposed actions that will result in changes to the "Progress Guide and General Plan" during the year, but such changes shall not become effective until enacted at the semi-annual hearing conducted for the purpose of amending the "Progress Guide and General Plan for The City of San Diego"; and

WHEREAS, the Council of The City of San Diego held a public hearing to consider the new "Mira Mesa Community Plan;" and

WHEREAS, the Council of The City of San Diego, by majority vote, approved the new "Mira Mesa Community Plan" and rescinded the existing "Mira Mesa Community Plan"; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That this Council hereby approved that plan entitled "Mira Mesa Community Plan," a copy of which is on file in the office of the City Clerk as Document No. 760167, which Plan was amended by the adoption of an amendment to page 77 of said Plan, a copy of which is on file in the office of the City Clerk as Document No. 760168.

2. That the new "Mira Mesa Community Plan" and the rescinding of the existing "Mira Mesa Community Plan" shall become effective upon adoption of an appropriate amendment to the "Progress Guide and General Plan for The City of San Diego," incorporating said plan, an omnibus hearing on this and other amendments having been scheduled on or about June 29, 1977.
