

RESOLUTION No. 218621 (R-77-2379).

Adopted on JUN 15 1977

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the City Manager be and he is hereby authorized and empowered to submit for and on behalf of said City, grant applications in the order of priority of projects as set forth in Attachment A to the ECONOMIC DEVELOPMENT ADMINISTRATION (EDA), U. S. DEPARTMENT OF COMMERCE, for financial assistance under Round II of the local Public Works Capital Development and Investment Program.

2. That the City Manager be and he is hereby authorized to execute grant agreements with the EDA for those projects approved for funding by the EDA.

3. That the San Diego Unified School District (School District) and The City of San Diego share the City's Round II Public Works Program grant amount as required by the public works legislation by combining the grant awards for School District and City for Round I and Round II, deducting projects already approved and funded for City School District projects and City, respectively, and sharing the remaining funds on a 50/50 basis.

4. That all requests for endorsement for local public works funding of school projects within the City be referred to the School District for funding under the 50% school share, and further that the City Manager be authorized to endorse any and all projects selected by the School District as required by the EDA up to an approximate amount of the 50% School District share of local public works monies.
