BE IT RESOLVED, by the Council of The City of San Diego as follows:

That if:

- 1) The Redevelopment Plan for the Gaslamp Quarter Redevelopment Project is not adopted prior to November 1, 1977; or
- 2) The Port Authority has not made an offer to the Navy to purchase Navy Field prior to November 1, 1977; or
- 3) The Agency has not entered into an exclusive negotiation agreement with a developer or developers for the development of all or part of the housing in the Marina Redevelopment Project prior to November 1, 1977; then

The date for Ernest W. Hahn, Inc. obtaining the commitments of three department stores shall be extended to March 1, 1978.


BE IT FURTHER RESOLVED, that if, after such extension:

- 1) The Redevelopment Plan for the Gaslamp Quarter Redevelopment Project is not adopted prior to March 1, 1978; or
- 2) The Port Authority has not made an offer to the Navy to purchase Navy Field prior to March 1, 1978; or
- 3) The Agency has not entered into an exclusive negotiation agreement for the development of housing in the Marina Project prior to March 1, 1978; then
