


**RESOLUTION No. 218641** (R-77-2367)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$34,994.00 by Trepte Bros. Development Co., a partnership, for CONSTRUCTION OF MISSION HILLS PARK COMFORT STATION in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 758835.
2. That the expenditure of \$887.00 is hereby authorized out of the Park Service District Fund (Fund 11571) and that the expenditure of \$18,966.00 is hereby authorized out of the Capital Outlay Fund (Fund 245) Unallocated Reserve of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF MISSION HILLS PARK COMFORT STATION in the City of San Diego, and related costs.
