BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$24,292.00 by DBX Inc., dba Perry Electric, a corporation for CONSTRUCTION OF TRAFFIC SIGNAL AND SAFETY LIGHTING SYSTEMS AT DEL MAR HEIGHTS ROAD AND MANGO DRIVE in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 759050.
2. That the expenditure of \$1,900.00 is hereby authorized out of the Capital Outlay Fund (Fund 245) and that the expenditure of \$32,510.00 is hereby authorized out of the Gas Tax Fund (Fund 220) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF TRAFFIC SIGNAL AND SAFETY LIGHTING SYSTEMS AT DEL MAR HEIGHTS ROAD AND MANGO DRIVE in the City of San Diego, and related costs.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$4,990.00 from CIP No. 61-138 to Gas Tax Reserve, CIP No. 90-220.
