RESOLUTION INVITING SEALED PROPOSALS FOR  
BIDS FOR THE CONSTRUCTION OF VARIOUS IMPROVE-  
MENTS IN 61ST STREET FROM SKYLINE DRIVE TO  
IMPERIAL AVENUE AND OF A SEWER MAIN IN BENSON  
AVENUE FROM 61ST STREET TO 65TH STREET.

WHEREAS, the public interest and convenience require the  
improvement herein referred to, and the Council intends to  
order the work and improvements described in Resolution of

Intention No. 218652, passed and adopted by the City

Council on JUN 22, 1977, and the plans, profiles and  
specifications therein referred to, be done and made; and

WHEREAS, the boundaries of the district to be assessed and  
the grades to which said work is to be done, is intended to be  
those described in said Resolution of Intention, and the plans,  
profiles and specifications therein referred to, reference to  
which is hereby made to all particulars; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,  
that the Purchasing Agent of The City of San Diego is hereby  
directed to post conspicuously, for five days, on or near the  
Council door, in the manner and form prescribed by law, the  
notice, together with a copy of the prevailing wage schedule  
established by Resolution No. 215808, inviting sealed proposals  
or bids for doing such work. Such notice shall state that the  
Purchasing Agent is the officer designated by the City Council  
to receive such bids and such notice shall give the time and  
place of the opening of any bids so received; and the Purchasing  
Agent is hereby directed to publish twice in the City Official  
Newspaper a notice inviting such proposals for doing the work;  
and the Purchasing Agent is hereby directed to record the results  
of such bidding to the City Council at the next regular City  
Council meeting after the opening of the bids; and the Purchasing  
Agent of The City of San Diego is hereby declared to be the  
officer to whom bids for such improvement work shall be presented  
or delivered.
