


RESOLUTION No. 218666 (R-77-2203)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Auditor and Comptroller is hereby authorized to reallocate \$39,650 from Capital Improvement Program 59-001 and \$10,350 from Capital Improvement Program 39-004, for a total of \$50,000, to Capital Improvement Program 34-002, Stadium Obligation Fund 245 for Fiscal Year 1977, and to transfer said \$50,000 to Stadium Fund 258 creating a total budget of \$1,102,000 for said Fiscal Year 1977.
