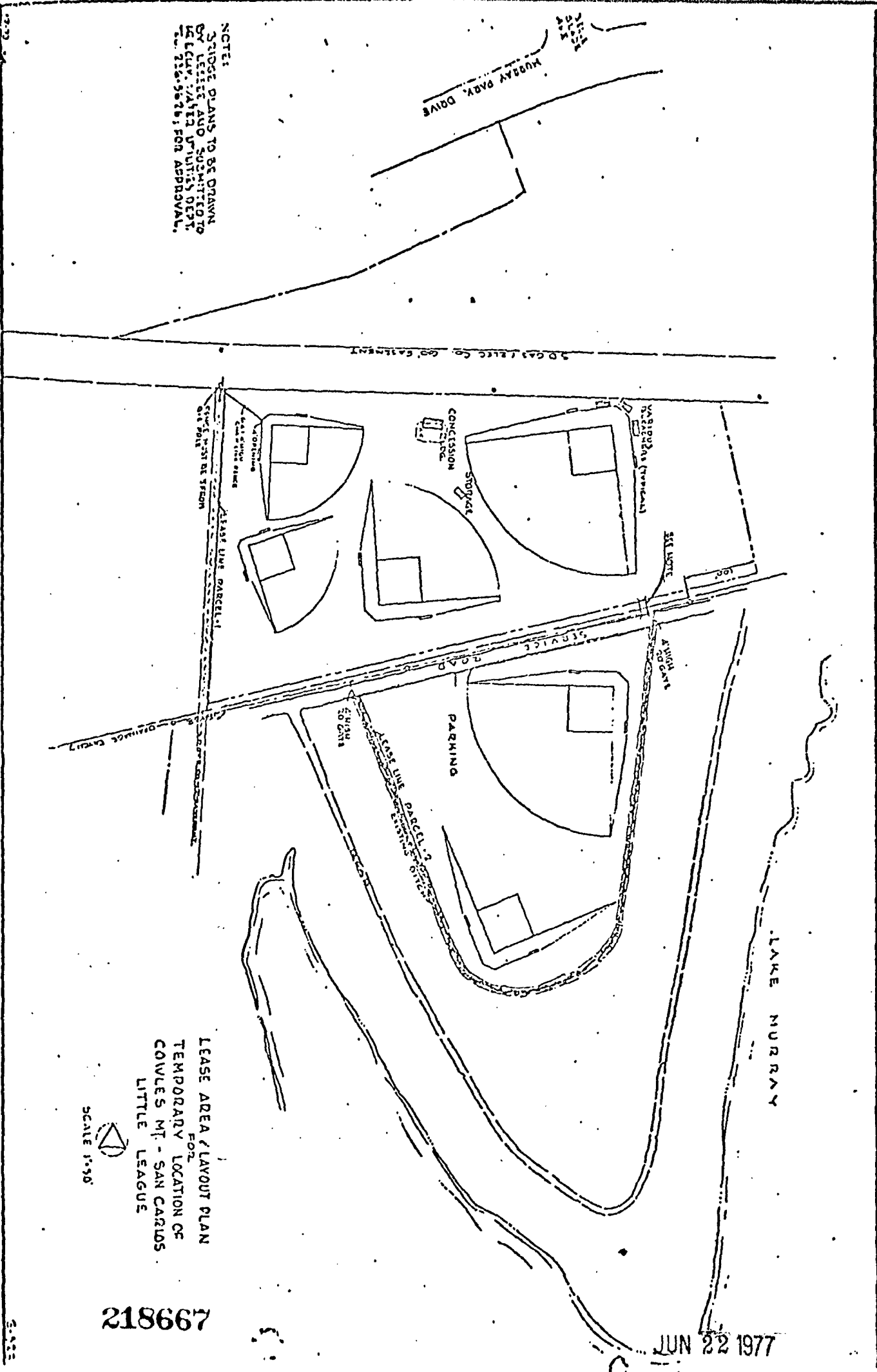
BE IT RESOLVED, by the Council of The City of San Diego as follows:

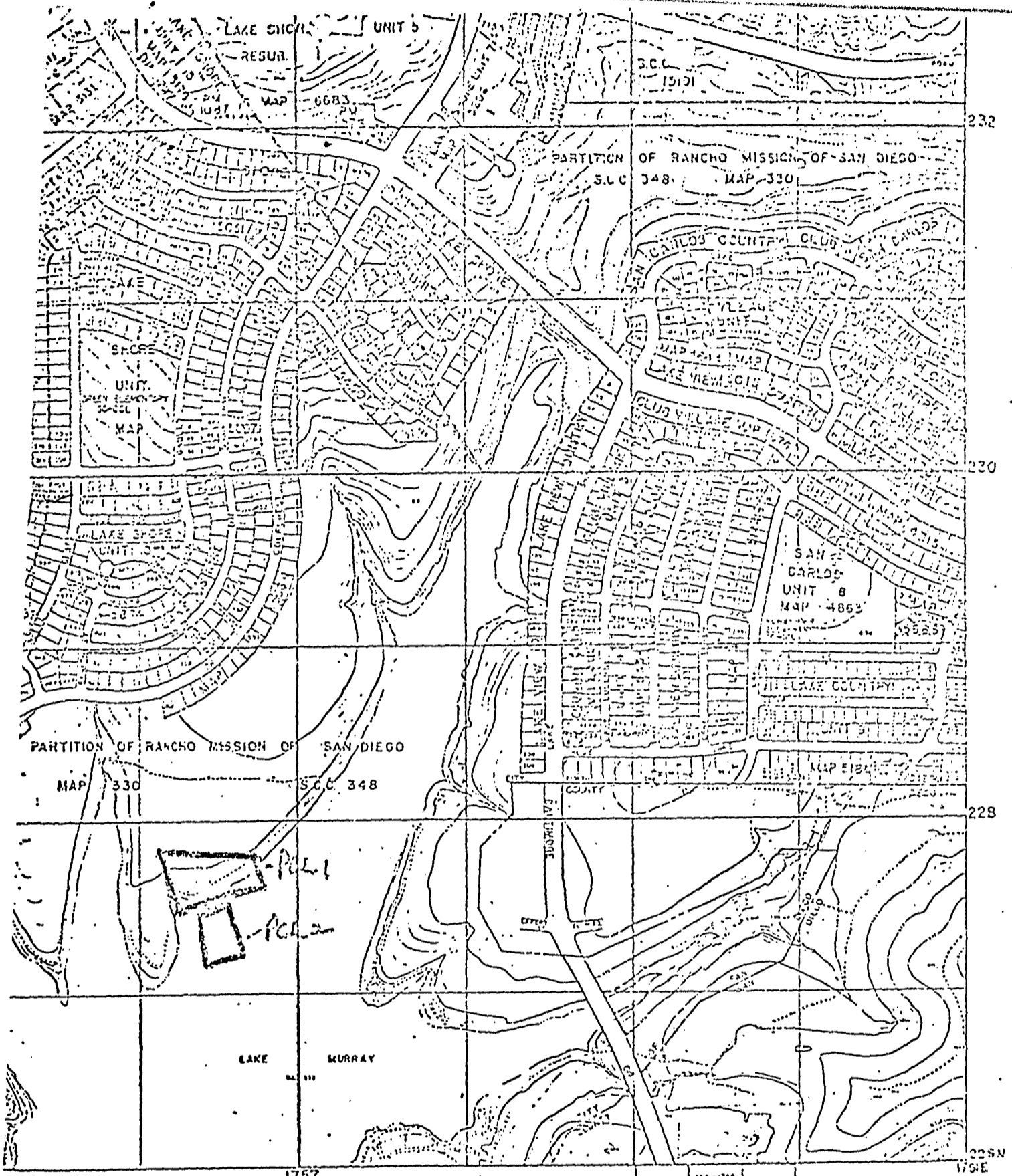
COWLES MOUNTAIN/SAN CARLOS, OE 2
