WHEREAS, a certain pedestrian and non-motor vehicular
easement was acquired for a development known as GENESEE
HIGHLANDS UNIT NO. 4; and

WHEREAS, the development of the property requires the abandonment
of a portion of said easement; and

WHEREAS, said existing easement will conflict with the proposed
development of the property; and

WHEREAS, the City will receive substitute facilities which will
replace a portion of the easement as part of the development of
GENESEE HIGHLANDS UNIT NO. 4; and


WHEREAS, the City has no present or prospective use for a portion
of the easement and the City Manager has recommended that the City
abandon its interest therein; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as
follows:

1. That the City of San Diego by this resolution does hereby
abandon whatever right, title or interest it may have in that portion
of the pedestrian and non-motor vehicular easement as more particularly
shown on Drawings 17147-1-D thru 17147-4-D, on file in the office
of the City Clerk as Document No. 759983, which are by this
reference incorporated herein and made a part hereof.

2. That the City Clerk shall cause a certified copy of this resolution, with drawings, attested by him under seal, to be recorded in the office of the County Recorder.
