BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of UNIVERSITY DEVELOPERS, a General Partnership, executed in favor of The City of San Diego, bearing date of March 3, 1977, granting to said City the permanent easements and right of way for a public street and incidents thereto, over, under, upon, along and across those portions of Lot 9, GENESEE HIGHLANDS UNIT. NO. 4, as more particularly described in said deed, be, and the same is hereby approved and the lands therein conveyed are hereby dedicated for and to public street purposes and the land therein described as Parcel 1 is hereby named CAMINO AGUILA, Parcel 2 is hereby named CAMINO CALMA, Parcel 3 is hereby named CAMINO LINDO and Parcel 4 is hereby named CAMINO NOGUERA.

BE IT FURTHER RESOLVED, that the City Clerk shall cause a certified copy of this resolution, with drawings, attested by him under seal, to be recorded in the office of the County Recorder.
