BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$515,869.45 by Cameron Bros. Const. Co., Inc., a corporation, for INSTALLATION OF THE 30th STREET PIPELINE, POLK AVENUE TO SUNCREST DRIVE, including Addendum A, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 758971.
2. That the expenditure of \$632,000.00 is hereby authorized out of the Water Revenue Fund (Fund 502) of the City of San Diego solely and exclusively for the purpose of providing funds for INSTALLATION OF THE 30th STREET PIPELINE, POLK AVENUE TO SUNCREST DRIVE, including Addendum A, in the City of San Diego, and related costs.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$111,000.00 from Annual Allocation Main Replacements (C.I.P. 73-083) to 30th Street Pipeline, Polk Avenue to Suncrest Drive, (C.I.P. 73-165).
