1. That the bid of \$173,638.05 by E. A. Rutledge, Inc., a corporation for CONSTRUCTION OF THE NORTH PARK STORM DRAIN - PHASE I in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 759048.
2. That the expenditure of \$161,000.00 is hereby authorized out of the Flood Control and Storm Drain Bond Fund (Fund 727) and that the expenditure of \$38,000.00 is hereby authorized out of the Gas Tax Fund (Fund 219) Reserve of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF THE NORTH PARK STORM DRAIN - PHASE I in the City of San Diego, and related costs.
