

RESOLUTION No. 218706 (R-77-2451)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$148,561.00 by Raymond D. Haas & Son, a partnership, for CONSTRUCTION OF PARADISE SENIOR CITIZENS' CENTER, Base Bid including Addenda A, B, C, and D, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 759064.
2. That the expenditure of \$37,558.00 is hereby authorized out of the Model Cities Fund (Fund 2550), that the expenditure of \$60,000.00 is hereby authorized out of the Senior Citizens' Building Fund (Fund 2671), that the expenditure of \$5,000.00 is hereby authorized out of the Gas Tax Reserve Fund (Fund 219), that the expenditure of \$40,000.00 is hereby authorized out of the CDBG Fund (Fund 2930), and that the expenditure of \$43,542.00 is hereby authorized out of the Capital Outlay Fund (Fund 245) Reserve of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF PARADISE SENIOR CITIZENS' CENTER, Base Bid including Addenda A, B, C, and D, in the City of San Diego, and related costs.





