1. That the bid of \$49,827.00 by Select Electric, Inc., a corporation, for the MODIFICATION OF TRAFFIC SIGNAL AND SAFETY LIGHTING SYSTEMS AT 12TH AVENUE AND F STREET: CAMINO DEL RIO SOUTH AND TEXAS STREET: JUAN STREET AND TAYLOR STREET: PRINCESS VIEW DRIVE AND WARING ROAD: TEXAS STREET AND UNIVERSITY AVENUE: INTERCONNECT ON UNIVERSITY AVENUE BETWEEN 35TH STREET AND WABASH AVENUE: AND MINOR IMPROVEMENTS AT TWENTY ADDITIONAL LOCATIONS, Base Bid including Additive Alternates Items 2 through 5, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 759053.
