BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$36,300.00 by TGS Electric Inc., dba Arrow Electric, a corporation, for the CONSTRUCTION OF TRAFFIC SIGNALS AND SAFETY LIGHTING SYSTEMS AT CAMINO DE LA REINA AND HOTEL CIRCLE NORTH AND AT FASHION VALLEY ROAD-HOTEL CIRCLE NORTH in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 759051.
2. That the expenditure of \$53,200.00 is hereby authorized out of the Capital Outlay Fund (Fund 245) of the City of San Diego solely and exclusively for the purpose of providing funds for the CONSTRUCTION OF TRAFFIC SIGNALS AND SAFETY LIGHTING SYSTEMS AT CAMINO DE LA REINA AND HOTEL CIRCLE NORTH AND AT FASHION VALLEY ROAD-HOTEL CIRCLE NORTH in the City of San Diego, and related costs.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$10,769.80 from CIP 61-122(7) and \$24,085.44 from CIP 61-120(7) to Capital Outlay Reserve Fund CIP 90-245.
