BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That CIP Project 34-022 be and it is hereby established in the amount of \$30,000 to Fiscal Year 1977.
2. That the bid of \$19,500 by Edward E. Arebalo dba Arebalo Enterprises for the REPAIR OF SETTLED CONCRETE SLABS AT SAN DIEGO STADIUM PLAZA LEVEL, Method A, including Addendum A, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 758422.
2. That the expenditure of \$7,000 is hereby authorized out of the Transient Occupancy Fund (Fund 223) and that the expenditure of \$23,000 is hereby authorized out of the Transient Occupancy Fund (Fund 224) of The City of San Diego solely and exclusively for the purpose of providing funds for REPAIR OF SETTLED CONCRETE SLABS AT SAN DIEGO STADIUM PLAZA LEVEL, Method A, including Addendum A, in the City of San Diego, and related costs.
