


**RESOLUTION No.** 218711 (R-77-2446)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$19,206.00 by DBX Inc., dba Perry Electric, a corporation, for the CONSTRUCTION OF TRAFFIC SIGNALS AND SAFETY LIGHTING SYSTEMS AT SANTA MONICA AVENUE AND SUNSET CLIFFS BOULEVARD in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 759049.
2. That the expenditure of \$26,206.00 is hereby authorized out of the Capital Outlay Fund (Fund 245) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF TRAFFIC SIGNALS AND SAFETY LIGHTING SYSTEMS AT SANTA MONICA AVENUE AND SUNSET CLIFFS BOULEVARD in the City of San Diego, and related costs.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$9,794.00 from CIP No. 61-125 to Capital Outlay Reserve, CIP No. 90-245 and the transfer of \$2,000.00 from CIP No. 61-125 to Gas Tax Unallocated Reserve, CIP No. 90-220.
