


RESOLUTION No. 218750 (R-77-2478)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, Supplement No. 2 to the Master Agreement under the Program of Local Agency Federal Aid Safety Improvement Projects with the STATE OF CALIFORNIA, DEPARTMENT OF TRANSPORTATION, covering use of Federal-Aid Section 230 Funds for the installation of automatic gates on CROSBY STREET (No. 2-269.4), JUNIPER STREET (No. 2-266.7) and VINE STREET (No. 2-265.8), in the City of San Diego, under the terms and conditions set forth in the form of Supplement No. 2 on file in the office of the City Clerk as Document No. 759887.

BE IT FURTHER RESOLVED, that the expenditure of \$18,100 is hereby authorized out of Capital Outlay Fund 245 of The City of San Diego, solely and exclusively for the purpose of providing matching funds for the above-referenced projects.
