RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO APPROVING AND PROVIDING FOR THE EXECUTION OF A PROJECT AGREEMENT FOR LAND AND WATER CONSERVATION FUND PROJECT NO. 06-00541, MORLEY FIELD EAST DEVELOPMENT, BY AND BETWEEN THE CITY OF SAN DIEGO AND THE STATE OF CALIFORNIA, RESOURCES AGENCY, DEPARTMENT OF PARKS AND RECREATION.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Section 1. The Project Agreement filed with the City Clerk as Document No. 759891, between The City of San Diego and the State of California under the terms of which provision is made for federal reimbursement of an amount not to exceed \$230,096 under provisions of the Land and Water Conservation Fund Act of 1965 for the development of Project No. 06-00541, Morley Field East Development, as described below:

This project will provide the development of a covered group picnic facility, picnic tables, barbecue pits, play equipment, road, lighting, irrigation system, landscaping, replacement of existing road with a pedestrian/bicycle path, comfort station, sewer line, volleyball and horseshoe court, water system and drinking fountain.

Section 2. The City Manager of the City of San Diego be and he is hereby authorized and directed to execute five copies of said Project Agreement.

Section 3. The City Clerk shall certify to the passage of this resolution by The City of San Diego and it shall thereupon take effect.
