RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO APPROVING AND PROVIDING FOR THE EXECUTION OF A PROJECT AGREEMENT FOR LAND AND WATER CONSERVATION FUND PROJECT NO. 06-00542, SOUTHEAST SAN DIEGO SPORTS FIELD, BY AND BETWEEN THE CITY OF SAN DIEGO AND THE STATE OF CALIFORNIA, RESOURCES AGENCY, DEPARTMENT OF PARKS AND RECREATION.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Section 1. The Project Agreement filed with the City Clerk as Document No. 759892 between The City of San Diego and the State of California, under the terms of which provision is made for federal reimbursement of an amount not to exceed \$116,955 under provisions of the Land and Water Conservation Fund Act of 1965 for the development of Project No. 06-00542, Southeast San Diego Sports Field, as described below:

This project is to provide for the final development of a 16-acre sportsfield complex. This construction will include grading, automatic irrigation system, lawn and landscaping on the remaining 8.4 acres at the site. Also included will be concrete pathways, three concrete benches, fifteen picnic tables with concrete slabs and five barbecue units. There will also be a tiny tots play area and a sand gym with volleyball provisions along with general park lighting and the undergrounding of overhead telephone lines at the site.

is hereby approved in all respects.

Section 2. The City Manager of The City of San Diego be and he is hereby authorized and directed to execute five copies of said Project Agreement.

Section 3. The City Clerk shall certify to the passage of this resolution by The City of San Diego and it shall thereupon take effect.


