WHEREAS, Ordinance No. 11998 (New Series) provides that appeals from certain administrative decisions and applications for waivers of utility undergrounding requirements shall be heard by a designated Standing Committee of the City Council; and

WHEREAS, there is a need to uniformly report the final results of such Standing Committee hearings; NOW, THEREFORE,

BE IT RESOLVED by the City Council of The City of San Diego, as follows:


1. That the final results of an appeal to a Standing Committee of the City Council shall be reported by a memorandum from the Committee Chairman to the members of the City Council with copies provided to the appellant, City Clerk and City Manager.

2. That the final results of an application to the Public Facilities and Recreation Committee for a waiver of underground utility requirements stating the undergrounding to be required shall be reported by a memorandum from the Committee Chairman to the members of the City Council with copies provided to the applicant, City Clerk, City Manager and public utilities involved.

3. That the Committee Chairman's memorandum shall advise that the decision of the Committee shall be the final administrative remedy in such matters unless a hearing is set before the City Council pursuant to Municipal Code Section 22.0101, Rule 4.

4. That the City Clerk is hereby directed to place on file his copy of the Committee Chairman's memorandum and that such copy shall become the official record of the results of the appeal or application to the Committee.
