That the City of San Diego hereby accepts the generous donation of a Disc Golf Course valued at \$6,000 from the WHAM-O Manufacturing Company to be installed in the East Morley Field at Balboa Park.

BE IT FURTHER RESOLVED, that the expenditure of \$6,000 is hereby authorized out of Capital Outlay Fund 245 of The City of San Diego, solely and exclusively, for the use of City Forces to install the course and purchase of miscellaneous installation material.

BE IT FURTHER RESOLVED, that this Council does hereby commend the WHAM-O Manufacturing Company for this act of civic generosity and does hereby publicly express on behalf of the citizens of San Diego a debt of gratitude to it.
