

RESOLUTION No. 218773 (R-77-1814)


Adopted on JUN 29 1977

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of three deeds of AVCO COMMUNITY DEVELOPERS INC., a California Corporation who acquired title as Rancho Bernardo Inc., a California Corporation, executed in favor of The City of San Diego bearing dates of February 11, 1977, conveying to said City the permanent easements and rights of way for drainage and sewers, affecting a portion of Rancho San Bernardo, as more particularly described in said deeds, be, and the same is hereby approved.
