

RESOLUTION No. 218775 (R-77-2404)


Adopted on JUN 29 1977 (revised)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a contract allocating \$775,000 in federal funds to the City for the purpose of performing 13 special projects under Title VI of the Comprehensive Employment and Training Act of 1973, as amended, under the terms and conditions set forth in the contract on file in the office of the City Clerk as Document No. 760962.
