BE IT FURTHER RESOLVED, that the expenditure of \$2,500 from Fund 100 (Unallocated Reserve), \$2,500 from Fund 2530 (CETA Newspaper Project), and \$2,500 from Fund 500 for a total of \$7,500 is hereby authorized for the sole and exclusive purpose of providing funds for the above project.
