

RESOLUTION No. 218798 (R-77-2437)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City of San Diego hereby accepts the generous donation of \$20,000 from the La Jolla Tennis Club to assist the City in providing tennis court lighting at the La Jolla High School.

BE IT FURTHER RESOLVED, that the expenditure of \$20,000 is hereby authorized out of Capital Outlay Fund 245 of The City of San Diego, solely and exclusively, for the City's share of the above-described improvement.

BE IT FURTHER RESOLVED, that \$10,000 from the Capital Outlay Fund 245 Cooperative Park Project of The City of San Diego, is hereby authorized to match a portion of the San Diego Unified School District's contribution valued in excess of \$19,000 for a total City contribution of \$30,000.

BE IT FURTHER RESOLVED, that this Council does hereby commend the La Jolla Tennis Club for this act of civic generosity and does hereby publicly express on behalf of the citizens of San Diego a debt of gratitude to it.
