APPROVING MAP OF LAUGHLIN SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by THOMAS H. SHUTTLEWORTH, a Licensed Land Surveyor, entitled "LAUGHLIN SUBDIVISION Being a subdivision of Lots 14 through 23 in Block 37 of Western Addition, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 315 filed in the office of the County Recorder of San Diego County, May 15, 1874 together with a portion of Xenophon Street as closed and vacated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: a portion of Worden Street, for public purposes; and said portion of a street is hereby declared to be a portion of a public street and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion of a public street is accepted on behalf of the public as heretofore stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
