| Eldon D. Smith | Police | \$1,000 | Sergeant Smith suggested that the Police Department cease evaluating temporary employees on a monthly basis, after the initial probationary period of one year. Since this is a time consuming procedure, an estimated \$19,553 has been saved since implementation. |
| Gerry A. DeLaye | Park and Recreation | \$ 655 | Mr. DeLaye is a District Recreation Supervisor in the Recreation Division. He suggested that supplies be ordered on a quarterly basis rather than monthly. This reduces the number of trips needed to be taken, and experience shows that an annual savings of \$6,537 is realized. |
| Gene Chouinard | Police | \$ 500 | Officer Chouinard suggested that the procedure for handling property tags and the disposal of evidence not needed for court be revised. This idea streamlines property procedures without any loss in accuracy. Estimated savings are \$9,688. This is a partial award pending final review |
| Herbert Michaels | General Services | \$ 500 | Mr. Michaels is a Refrigeration Mechanic in the Buildings Division He suggested that pneumatic switches be installed in the Main Library heating/cooling system so that these systems may be shut down when the building is not in use. Estimated savings are expected to be \$12,496. This is a partial award pending a final |
