

RESOLUTION NO. 218827

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
George E. Perkins	Fire	\$ 75	Mr. Perkins is an Engineer. He suggested a revision to the air system of crash and rescue vehicles at Lindbergh Field. His idea allows these vehicles to maintain sufficient air pressure at all times and saves \$750 annually in fuel costs.
Walter T. Wickware	General Services	\$ 70	Mr. Wickware is a Senior Solid Waste Supervisor in the Solid Waste Division. He suggested that a supervisor pick up the dust control vehicle used at Chollas on the way to work. This eliminates multiple trips by two persons to get the vehicle. Estimated annual savings are \$1,395, and this is a partial award pending a final review.
Carmen C. Lutes	Engineering and Development	\$ 65	Ms. Lutes is an Intermediate Stenographer in the Permits Section. She suggested that certain forms be placed on larger paper to reduce the microfilming costs when more than one sheet was used. This is expected to save \$1,300 annually. This is a partial award pending a final review.
Carmen C. Lutes	Engineering and Development	\$ 35	Ms. Lutes suggested the use of window envelopes in mail processing for the Permits Section. This saves the City an estimated \$367 annually.
Jack B. Clark Melvyn E. Medhurst	Fire	\$ 30	Captain Clark and Engineer Medhurst revised equipment maintenance forms. These forms are easier to use and gather more information than the previous forms. Savings are difficult to calculate, but the revision provides benefits.
