

RESOLUTION NO. 218828Adopted on JUL 20 1977

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Harry R. Reid	General Services	\$ 30	Mr. Reid is a Locksmith in the Buildings Division. He suggested that key code records for all City vehicles be kept at 20th and B. This saves \$300 per year in time spent replacing lost keys.
Thomas C. Feldscher	Fire	\$ 25	Mr. Feldscher is a Fire Fighter. He suggested that a standard building evacuation signal be used. This has been done and is felt to be a significant safety idea.
Ascencion Reyes	Property	\$ 20	Mr. Reyes is a Gardener at the Stadium. He designed a tow bar attachment for the batting cage. Since this was formerly moved by hand, this is considered to be a significant safety improvement.
Janet M. Sorrell	Fire	\$ 15	Ms. Sorrell is an Intermediate Stenographer. She suggested that recording equipment be converted from battery power to direct current. This prevents the continual purchase of batteries and is expected to save both time and money.
W. Bronson Rideout	Building Inspection	\$ 10	Mr. Rideout is an Associate Structural Engineer. He revised a form to include more information. This saves approximately \$100 annually in checking time.
Carmen C. Lutes	Engineering and Development	\$ 10	Ms. Lutes is an Intermediate Stenographer. She developed a sample sheet for notary acknowledgments which aids notaries in providing the City with proper documents. This saves approximately \$100 annually in correcting errors.
