APPROVING MAP OF LANSING SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by GUY W. WINTON, JR., a Registered Civil Engineer, entitled "LANSING SUBDIVISION Being a subdivision of a portion of Pueblo Lot 1234 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to Map thereof made by James Pascoe in 1870, a copy of which was filed in the office of the County Recorder of said San Diego County, and is known as Miscellaneous Map No. 36." is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the alley for public purposes; and said alley is hereby declared to be a public alley and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of vehicular access in and to Clairemont Mesa Boulevard, adjacent and contiguous to Lot 1, all as shown on this map within this subdivision and subject to the conditions set forth thereon.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
