That the petition for the construction of certain improvements of HOPKINS STREET from Winchester Street to Roanoke Street, under the provisions of the Improvement Act of 1911, consisting of one sheet and filed under Document

No. 760321, is hereby granted.

BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby directed to prepare plans, drawings, typical cross-sections, profiles and specifications for the improvement of HOPKINS STREET from Winchester Street to Roanoke Street, in the City of San Diego, by the grading and paving and the installation of curbs, gutters and sidewalks, together with estimates of the costs and expenses of such work and to furnish this Council with a description of the district to be included in the assessment for the work and improvements hereinabove mentioned.
