## RESOLUTION OF INTENTION NO. 218847

RESOLUTION ELECTING TO PROCEED UNDER THE PROVISIONS OF THE STREET VACATION ACT OF 1941, DECLARING THE INTENTION OF THE CITY COUNCIL TO VACATE MYRTLE AND SPOKANE AVENUES, COLFAX STREET, 39TH STREET, AND ALLEY, BLOCK 111, MAP 1007, AND FIXING A TIME AND PLACE FOR HEARING THEREOF.

BE IT RESOLVED, by the Council of The City of San
Diego, that the public interest and convenience of said City
require the vacation of a portion of the streets hereinafter
mentioned; and in connection therewith require the reservation
of certain easements for water and drains in the area
covered by such street.

BE IT FURTHER RESOLVED, that it is the intention of said Council to order the vacation of Myrtle and Spokane Avenues, Colfax Street, 39th Street, and Alley, Block 111, Map 1007, as more particularly shown on Drawing No. 17150-D, on file in the office of the City Clerk as Document No. 760244 .

The Council hereby elects to proceed, in making said vacation, under the provisions of the "Street Vacation Act of 1941."

The Council hereby fixes 2:00 P.M., AUG 17 1977 in the Council Chamber on the twelfth floor of the City Administration Building, Charles C. Dail Concourse, 202 "C" Street, in said City of San Diego, as the time and place for hearing all persons interested in or objecting to the proposed vacation.
