WHEREAS, a petition was received by the City Clerk for the formation of a park district under the provisions of the San Diego Park District Procedural Ordinance of 1969, said petition (including supplementary petition dated May 19, 1977) being filed in the office of the City Clerk on June 6, 1977 as Document No. 759512; and

WHEREAS, this petition has been checked by the City Clerk; and

WHEREAS, the City Clerk has certified in a certificate filed in his office on June 30, 1977 as Document No. 759829 that the petition contains signatures representing 78.8% of the area of the assessible lands in the proposed district as shown by the last equalized assessment roll upon that date; and

WHEREAS, the City desires to acknowledge the petition for said district; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the receipt of the petition for the formation of a park district under the provisions of the San Diego Park District Procedural Ordinance of 1969 in the Bankers Hill Canyon area, on file in the office of the City Clerk as Document No. 759512 is hereby acknowledged.

2. That the City Manager is hereby directed to prepare plans for the acquisition, improvement and maintenance of the lands shown on Exhibit A of said petition, together with the

estimates of the costs and expenses of such acquisition, improvement and maintenance, to prepare an estimate of the assessment to be levied on each parcel of property within the proposed district, and to furnish this Council with a description of the district and a plat showing the exterior boundaries of the district to be included in the assessment for said acquisition, improvement and maintenance; said acquisition, improvement and maintenance to be done under the San Diego Park District Procedural Ordinance of 1969.
