That the expenditure, not to exceed \$1,780, is hereby authorized out of the Capital Outlay Fund 245, C.I.P. No. 20-001(7) of The City of San Diego, solely and exclusively for the purpose of providing funds for restroom improvements at the Highland-Landis Park and Recreation Center.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to do by City forces the necessary work to install restroom improvements at Highland-Landis Park and Recreation Center, pursuant to recommendation of the City Manager and submission of estimates by him indicating that said work can be done by City forces more economically than if let by contract.
