WHEREAS, the Planning Department has reviewed said operating procedures and responsibilities for each of the hereinafter mentioned Community Planning Committees, found them to be in conformance with Council Policy 600-24, and has recommended each for official recognition; and

WHEREAS, the Rules Committee of the City Council on March 14, 1977, reviewed the matter and recommended each of the hereinafter mentioned Community Planning Committees for official recognition; NOW, THEREFORE,


