RESOLUTION OF FINDING OF MITIGATION, FEASIBILITY
OR PROJECT ALTERNATIVES PURSUANT TO CALIFORNIA
PUBLIC RESOURCES CODE SECTION 21081.


BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

That in connection with the City's quitclaim of an
easement for right of way to the County of San Diego for
MAST BOULEVARD, for which action an Environmental Impact
Report has been prepared (County Log No. 74-14-407, dated
July 11, 1974), the Council finds that the mitigation measures
and factors as specified and contained in the attached document
dated July 20, 1977 from the County of San Diego, Department
of Transportation, together with the following beneficial
impacts, cumulatively outweigh and effectively mitigate the
adverse impacts as described in the Environmental Impact
Report:

1) The proposed extension will reduce existing congestion
at the intersection of Mission Gorge Road with Carlton Hills
Boulevard and will contribute to a more efficient distribution
of vehicular traffic; and

2) Construction of the Mast Boulevard along the planned
right of way is in accordance with the Circulation Element of
the San Diego County General Plan.


