That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

James N. Burgess Andrew Chavez William R. Cotton	Water Utilities	\$ 450	All three suggesters are Equipment Technicians in the Utilities Systems Division. They suggested a revision in compound water meter testing and calibrating procedure. This idea is expected to save \$7,888 a year in time and water. This is a partial award pending a final review.
Eleanor M. Wells	Auditor & Comptroller	\$ 250	Ms. Wells is an Account Clerk. She suggested that Park and Recreation personnel charge subdividers via job orders for the time spent in inspecting for compliance with landscaping plans. This is expected to save the City \$5,014 annually. This is a partial award pending final review.
John A. Barton	Property	\$ 125	Mr. Barton is a Gardener Supervisor at San Diego Stadium. He designed a stolon planter for use in conversion from baseball to football. This is expected to save the City \$2,500 annually. This is a partial award pending a final review.
Kenneth C. Bouchard	Water Utilities	\$ 115	Mr. Bouchard is a Utilities Supervisor in the Utilities Systems Division. He designed a drilling rod machine adaptor that reduces the time needed to install water lines. This is expected to save the City \$2,308 annually. This is a partial award pending a final review.
