BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and directed to execute, for and on behalf of The City of San Diego, an amendment to the subdivision agreement for MONTEZUMA TOWNHOUSE, to provide for the substitution of FRED S. MACOMBER for RESERVOIR PROPERTIES, a limited partnership, KENNETH LEO FLOR, BETTY AILENE FLOR, C. H. WATT, and ISABEL BEDFORD as subdivider, under the terms and conditions set forth in the form of Amendment to Subdivision Improvement Agreement for MONTEZUMA TOWNHOUSE, on file in the office of the City Clerk as Document No. 760355.

BE IT FURTHER RESOLVED, that Bond No. SUR 24023, issued by MISSION INSURANCE COMPANY, in the amount of \$274,693.00, is hereby accepted as improvement security for the performance of the public improvements, and that Bond No. 305150, issued by the SUMMIT INSURANCE COMPANY OF NEW YORK, is hereby released.

BE IT FURTHER RESOLVED, that the public improvements to be constructed pursuant to the aforementioned subdivision agreement shall be completed by July 1, 1979, as provided by the amendment to the subdivision agreement.
