WHEREAS, SAN DIEGO UNIFIED PORT DISTRICT, a public corporation, has requested an exchange of easements on property owned by it in order to conform to the as-built improvements which allow better utilization of the property; and

WHEREAS, the City Manager has certified that the value of the property rights to be exchanged are approximately equal; and

WHEREAS, the easement to be acquired will serve the same use and purpose as the easement to be quitclaimed by the City; and

WHEREAS, this action is exempt from the provisions of the California Environmental Quality Act of 1970 under the City guidelines for implementation of said Act, as amended; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego as follows:

That the acceptance by the City Manager of that deed of SAN DIEGO UNIFIED PORT DISTRICT, a public corporation, executed in favor of the City of San Diego, conveying to said City a portion of the Unified Port District Tidelands, for the purpose of construction, operation, maintenance, repair, replacing and inspection of a sixteen inch water main placed below the level of the surface of the ground, as more particularly described in said deed, is hereby approved.

- 3. That the City Clerk of said City is hereby authorized and directed to deliver said deeds and a certified copy of this resolution to the Property Director for further handling.
